# **Background Information**

Southwest Arkansas Counseling and Mental Health Center is a non-profit 501(c) organization that originated in 1967 as the Greater Texarkana Mental Health and Mental Retardation Center. The name was changed to Southwest Arkansas Counseling and Mental Health Center, Inc. in 1974. The mission of the Southwest Arkansas Counseling and Mental Health Center, Inc. is to prevent, treat, and cure mental illnesses and related disorders regardless of an individual's ability to pay for such services.

The Center's philosophy is that services should be provided to individuals and families in a way which promotes the rights, dignity, health and safety of the clients through enhancement of their independence (financial and emotional), self-sufficiency, and quality of life; that the likelihood of achieving the goals of treatment is enhanced by having clients and their families actively participate in all phases of treatment; and that the quality of services is improved by the utilization of the collective expertise of staff members representing various disciplines, working toward goals which are attainable and measurable.

It is also the philosophy of the Center that clients should be served in the least restrictive environment possible. Further, it is the Center's philosophy that comprehensive mental health services include not only treatment and therapeutic efforts by the clinical staff, but also preventative efforts through public education and dissemination of information that promotes positive mental health in individuals and families throughout the areas served by the Center.

The Center provides mental health services to Arkansas residents residing in Hempstead, Howard, Layfayette, Little River, Miller and Sevier Counties regardless of age, gender, sexual orientation, social preferences, cultural orientation, race, color, physical status/disability, spiritual beliefs/religion, ability to pay for services, nation of origin, psychological characteristics, or involvement in the adult or juvenile criminal justice system. We have approximately 240 employees center wide that provide a variety of services to our community. Youth Services are also provided in Pike and Nevada Counties. Substance abuse services are provided to residents of Columbia, Calhoun, Dallas, Hempstead, Howard, Layfayette, Little River, Miller, Nevada, Ouachita, Sevier, and Union Counties.

It is the policy of the Center to provide services to clients in a way that protects their rights and respects their dignity. To this end, the Center has adopted a set of rights and responsibilities for clients as well as a grievance procedure designed to safeguard these rights. These rights are intended to ensure Center clients receive the highest quality of care in an atmosphere that is characterized by professionalism, ethical practice, dignity, and respect.

# Similar Projects

Southwest Arkansas Counseling and Mental Health Center, Inc. has participated in several projects over the years. A description of each can be found below.

#### DCFS Counseling Contract

We currently have a contract with the Division of Children and Family Services (DCFS) to provide Counseling services for DCFS clients in order to prevent out-of-home placement of children and to promote reunification of families. We are providing these services to individuals residing in Miller, Layfayette, Little River, Hempstead, and Sevier Counties. We have a total of 7 therapists who provide these services and approximately 8 staff members that help to set up appointments and complete billing.

Services provided include diagnostic assessment, treatment planning, individual therapy, and family therapy as needed.

#### Therapeutic Foster Care

In 1981, the Arkansas Department of Human Services, Division of Children and Family Services contracted with the Center to establish a therapeutic foster care program. The Therapeutic Foster Care Program of Southwest Arkansas Counseling and Mental Health Center (SWACMHC) is an intensive program designed to address the needs of children 3 to 21 years of age in DCFS custody, who have been classified as having behavioral and/or emotional disturbance. Clients that reside in the Center's catchment area are given priority. The catchment area countries include Hempstead, Howard, Lafayette, Little River, Miller and Sevier Counties.

Treatment for the children is provided within a structured home environment by trained therapeutic foster parents, who are supervised by the TFC Program Director, or his/her designee. SWACMHC'S TFC program currently has 17 Therapeutic homes and 20 children placed with the capacity to house 23 children.

Each child placed in SWACMHC's TFC program is provided the following services:

- Mental Health Initial Diagnostic Evaluation
- Treatment Planning
- Psychiatric Evaluation
- Therapeutic Services (including individual therapy, family therapy, multi-family therapy, group therapy, and psychoeducation)
- Paraprofessional services
- Crisis Interventions

In addition, each child will also be offered the following additional services as outlined in their individual treatment plan:

- Medication Management
- Group Therapy
- After-School Group
- Summer Programs
- Spiritual Activities
- Transportation
- Court Attendance
- Extracurricular Activities
- Medical Appointments (as needed, as required)
- Community Activates
- Parent Support Group
- Respite
- Psycho-educational Testing (if indicated)

Staff delivering services to TFC children will work closely with the foster families and schedule appointments convenient for the child and the family. We provide services in the clinic, in the home, and in the school. In addition our staff work very closely with DCFS, CASA, Attorney Ad-Litems, and PASSE Care Coordinators to ensure our children receive the best care possible. We are committed to working as a team and believe everyone needs to work together to help these children and their families stabilize. We have 7 full-time staff members that work with the Therapeutic Foster Care Program: the Children's Services Director, TFC Secretary, Therapeutic Foster Care Program Director who also serves as the TFC primary therapist, two Mental Health Paraprofessionals, a Behavioral Specialist, and our Director of TFC Recruitment.

#### Therapeutic Day Treatment (TDT)

Southwest Arkansas Counseling and Mental Health Center worked in tandem in 2018 with the Texarkana Arkansas School District to provide Therapeutic Day Treatment (TDT) to Texarkana, Arkansas students (grades K-12) in need of a more structured environment. The program was

designed to help students and families reduce barriers to learning while improving the emotional and behavioral development of students. The TASD school district collaborated efforts with Southwest Arkansas Counseling and Mental Health Center, Inc. to ensure the best treatment is provided to the students.

The TDT program was structured to resemble the regular classroom as much as possible with the addition of mental health experts in order to help the students learn to adjust to a structured classroom setting while receiving the necessary support to keep them stabilized. While in the TDT program, students received education from highly trained and certified special education teachers. In addition, students received one-on-one therapy from a licensed Mental Health Professional as well as group therapy, family therapy, and paraprofessional services. SWACMHC strongly believes in the healing power of the family unit and structured the program to encourage families to be involved in their child's educational and therapeutic journeys.

#### Infant Mental Health

Southwest Arkansas Counseling and Mental Health Center, Inc. is a certified Infant-Mental Health Agency with the Department of Human Services. We currently have 6 certified Infant-Mental Health (IMH) therapists that provide treatment for children 0-47 months and their families. Our IMH therapists are trained in evidence-based treatments specifically designed to improve the social and emotional foundation of these young children. The therapies used focus on treating the whole family, not just the infant. They work on improving the relationship between the adult and infant by focusing on strengthening the parent-child relationship and improving the parenting skills by increasing the levels of attunement.

#### Lewisville Juvenile Detention Center

In ??? of 2017, Southwest Arkansas Counseling and Mental Health Center contracted with the state to provide therapeutic services to juveniles at the Juvenile Detention Center in Lewisville, AR. The complex can house up to 32 juveniles who have been charged with crimes and have mental health issues. We have a therapist that provides individual therapy, group therapy, and family therapy as well as a substance abuse counselor who provides substance abuse groups for those with co-occurring mental health and substance abuse issues.

#### Youth Services

Southwest Arkansas Counseling and Mental Health Center's (SWACMHC) Youth Services program provides Probation and Case Management services to adjudicated youth through the Juvenile Courts in our area. The goal of the Youth Services Program is to reduce juvenile delinquency. To accomplish this goal, the Youth Services Program serves delinquent and high-risk youth that reside in an 8-county catchment area of Southwest Arkansas. One or more full-time Case Managers serve each county. Most youth served by the Program are Juvenile Court referrals, but referrals may come from any source. The four Judicial districts served are 9 West, 8 South, 8 North and the 13th. These Districts encompass 13 counties with approximately 300-350 young people and their families being served at any one time.

It is our job to ensure all Court orders are followed by the juvenile and parent(s)and/or guardians, along with maintaining personal contact and supervision to ensure a successful outcome for each case. Also, our agency provides Diversion services and supervision programs to non-adjudicated young people who, at the request of a parent or guardian, may require minimal services or supervision without going through formal juvenile court proceedings.

#### Substance Abuse

Substance abuse services through Southwest Arkansas Counseling and Mental Health Center were established in 1999. This included a residential program, River Ridge Treatment Center, outpatient services, and intensive outpatient services through the offices in Texarkana and Hope, and detox services (contracted through River Ridge). Substance Abuse Outpatient Services became accredited through CARF in 2009 (Integrated AOD/MH for Adults, Adolescents and Children) and Residential Services in 2012 (Adults).

We currently have a contract with the Division of Behavioral Health Services (DBHS) to provide substance abuse treatment to individuals in a 12 county area (Columbia, Calhoun, Dallas, Hempstead, Howard, Layfayette, Little River, Miller, Nevada, Ouachita, Sevier, and Union Counties). This contract allows us to provide outpatient services, intensive outpatient services, partial-day, and residential services to individuals struggling with substance abuse. Residential services are provided 24/7 at River Ridge Treatment Center. Outpatient services are provided Monday-Thursday between the hours of 8am and 5pm with aftercare classes occurring after 5pm. Currently we provide residential, partial-day, and outpatient services to adults over the age of 18yo and juvenile substance abuse outpatient services.

River Ridge Treatment Center opened September 11, 2000. The programs capacity is 8 female clients and 15 male clients. Residential treatment is provided in accordance with DBHS guidelines and Rules of Practice. River Ridge Treatment Center currently has ten full time employees. This includes the Director of Substance Abuse Services, a clinical supervisor, three

counselors, three house managers, an administrative assistant and a cook/facility manager. Through he contract we serve on average 16 individuals a month at River Ridge.

Outpatient and Intensive Outpatient services were established in July of 1999, when SWACMHC assumed responsibility for substance abuse services in Catchment Area 10. Initially these services were offered in Hope and Texarkana. In 2014, services were expanded to include DeQueen, Magnolia and El Dorado. Each of these offices employs one full-time counselor to provide needed services. Through the contract, we are able to serve approximately 50 people a month on an outpatient basis.

Detoxification services have been provided for Catchment Area 10 since July of 1999. These services are provided under contract with Ouachita County Medical Center in Camden. SWS services have been offered since 2014, via contract with OMART in Gassville, Arkansas Cares in Little Rock and New Beginnings in Warren.



#### TF-CBT training for CTG – July, 2014

Childhood Traumatic Grief (CTG) is a condition believed to develop in some children following the traumatic death of a significant person in their lives. Children with CTG develop some symptoms which resemble those seen in Posttraumatic Stress Disorder (PTSD). CTG treatment addresses both the trauma and grief symptoms, with resolution of the traumatic aspects first.

#### Parenting the Love and Logic Way Facilitator (7yo and up)

Many parents want their kids to be well prepared for life, and they know this means kids will make mistakes and must be held accountable for those mistakes. But these parents often fail to hold the kids accountable for poor decisions because they are afraid the kids will see their parents as being mean. The result is they often excuse bad behavior, finding it easier to hold others, including themselves, accountable for their children's irresponsibility. This curriculum teaches parents how to hold their kids accountable. The Love and Logic method causes the child to see their parent as the "good guy" and the child's poor decision as the "bad guy." When done on a regular basis, kids develop an internal voice that says, "I wonder how much pain I'm going to cause for myself with my next decision?" Kids who develop this internal voice become more capable of standing up to peer pressure.

When parents start Love and Logic® early in their children's lives, they dramatically up the odds that the teenage years will be fun...instead of frantic. They also create kids who'll begin school ready to learn...instead of ready to drive their teachers batty. With this curriculum, you will have an easy-to-teach, powerfully practical set of tools for helping parents of infants, toddlers and preschoolers raise super kids.

#### Completed basic training in EMDR (Eye Movement Desensitization and Reprocessing) – February, 2016

EMDR is an evidence-based psychotherapy for Posttraumatic Stress Disorder (PTSD). In addition, successful outcomes are well-documented in the literature for EMDR treatment of other psychiatric disorders, mental health problems, and somatic symptoms. The model on which EMDR is based, Adaptive Information Processing (AIP), posits that much of psychopathology is due to the maladaptive encoding of and/or incomplete processing of traumatic or disturbing adverse life experiences. This impairs the client's ability to integrate these experiences in an adaptive manner. The eight-phase, three-pronged process of EMDR facilitates the resumption of normal information processing and integration. This treatment approach, which targets past experience, current triggers, and future potential challenges, results in the alleviation of presenting symptoms, a decrease or elimination of distress from the disturbing memory, improved view of the self, relief from bodily disturbance, and resolution of present and future anticipated triggers.

#### Facilitating Support Groups for Victims of Domestic Violence - June 22, 2010

- Domestic Violence is the most common cause of serious injury among women in the United States, accounting for more injuries than car accidents, muggings, and rapes combined and can have detrimental effects on those who experience it including depression, psychological distress, low self-esteem, posttraumatic stress disorder, anxiety, substance abuse, and sleeping problems. In addition, research shows that as many as 17.8 million children witness some form of domestic violence in their lifetime. The results on children of witnessing this abuse have effects on their physical, biological, emotional, social, and cognitive development and place these children at a higher risk of hyperactivity, posttraumatic stress, and impulsive and violent behaviors. Research shows that counseling and support groups can be effective in improving self-esteem, affect, social support, focus of control, coping abilities, and self-efficacy for women and children exposed to domestic violence. This training equips individuals with the tools and knowledge necessary to confidently lead and facilitate a support group for women who have been abused sexually, emotionally, and/or physically and assist individuals in supporting children who have been affected by abuse.

# TF-CBT: Trauma Focused Cognitive Behavioral Therapy for Children who have Experienced Trauma – June 28, 2010

- TF-CBT is the most rigorously tested treatment for traumatized children. It addresses all types of trauma
  including sexual abuse, physical abuse, traumatic grief, domestic violence, natural disasters, terrorist acts, and
  accidents. The goal of TF-CBT is to help address the bio-psycho-social needs of children and their parents or
  primary caregivers. TF-CBT is a model of psychotherapy that combines trauma-sensitive interventions with
  cognitive behavioral therapy. Children and parents are provided knowledge and skills related to processing the
  trauma including managing distressing thoughts, feelings, and behaviors; enhancing safety, parenting skills, and
  family communication.

#### Mental Health in the Preschool Classroom - October 22, 2010

- Research on brain development shows that a child's environment is crucial during the infant and toddler years. 
