SECTION 1 - GENERAL INSTRUCTIONS AND INFORMATION

1.1 PURPOSE

This Invitation for Bid (IFB) is issued by the Department of Human Services (DHS) Office of Procurement (OP) for the Division of Aging, Adult, and Behavioral Health Services (DAABHS) to obtain pricing and a contract for diagnostic laboratory test services for the Arkansas State Hospital.

1.2 TYPE OF CONTRACT

- A. A Term contract will be awarded to a single vendor.
- B. Any resultant contract of this *Bid Solicitation* **shall** be subject to State approval processes which may include Legislative review.
- C. The term of this contract **shall** be for one (1) year. The anticipated starting date for the contract is July 1, 2021. Upon agreement by the vendor and agency the contract may be renewed by the Office of Procurement (OP) on a year-to-year basis, for up to six (6) additional one-year terms or a portion thereof not to exceed a total aggregate contract term of seven (7) years.

1.3 ISSUING AGENCY

The OP, as the issuing office, is the sole point of contact throughout this solicitation process. Vendor questions regarding this Bid Solicitation should be made through the State's buyer as shown on page two of this document. Vendor's questions will be answered as a courtesy and at vendor's own risk.

1.4 BID OPENING LOCATION

Bids submitted by the opening time and date shall be opened at the following location:

Department of Human Services Office of Procurement 700 Main Street Little Rock, AR 72201

Vendors wishing to attend the bid opening must report to the main entrance location, Arkansas Department of Human Services, Donaghey Plaza South Building, 700 Main Street, Little Rock, Arkansas 72201 and check in with the receptionist. All attendees are required to obtain security clearance upon entrance to the building by submitting a current, valid photo ID, preferably a driver's license, to the Security Officer at the reception area. The Security Officer will issue a visitor's badge which must be worn at all times. Before leaving the bid opening, visitors are required to return the visitor's badge to the Security Officer and retrieve their ID.

The receptionist is to contact the buyer, for the vendor, for more detailed directions to the bid opening location.

When circumstances warrant, DHS may elect to conduct the bid opening entirely via video conference. If DHS makes this election, DHS shall post a link to the video conference on its website. If the bid opening will be conducted entirely via video conference, individuals will not be permitted to attend in-person.

1.5 DEFINITION OF REQUIREMENT

- A. The words "**must**" and "**shall**" signify a Requirement of this solicitation and that vendor's agreement to and compliance with that item is mandatory.
- B. Exceptions taken to any Requirement in this *Bid Solicitation*, whether submitted in the vendor's bid or in subsequent correspondence, **shall** cause the vendor's bid to be disqualified.
- C. Vendor may request exceptions to NON-mandatory items. Any such request **must** be declared on, or as an attachment to, the appropriate section's *Agreement and Compliance Page*. Vendor **must** clearly explain the requested exception and should reference the specific solicitation item number to which the exception applies. (See *Agreement and Compliance Page*.)

1.6 DEFINITION OF TERMS

A. The State Procurement Official has made every effort to use industry-accepted terminology in this *Bid Solicitation* and will attempt to further clarify any point of an item in question as indicated in *Clarification of Bid Solicitation*.

- B. The words "bidder," "vendor," and "contractor" are used synonymously in this document.
- C. The terms "Invitation for Bid", "IFB" and "Bid Solicitation" are used synonymously in this document.

1.7 RESPONSE DOCUMENTS

- A. Bid Response Packet
 - 1. An official authorized to bind the vendor(s) to a resultant contract **must** sign the *Bid Signature Page*.
 - 2. Vendor's signature on this page **shall** signify vendor's agreement that either of the following **shall** cause the vendor's bid to be disqualified:
 - a. Additional terms or conditions submitted intentionally or inadvertently.
 - b. Any exception that conflicts with a Requirement of this Bid Solicitation.
 - 3. The following items **shall** be submitted with the *Bid Response Packet in a sealed envelope*:
 - a. EO 98-04 Disclosure Form (Attachment A).
 - b. Copy of Vendor's Equal Opportunity Policy. (See Equal Opportunity Policy.)
 - c. Signed addenda to this IFB, if applicable. (See Requirement of Addendum.)
 - d. Documentation that vendor meets the minimum qualifications outlined in this IFB. (See *Minimum Qualifications*.)
 - 4. **DO NOT** include any other documents or ancillary information, such as a cover letter or promotional/marketing information. **Submit one (1) electronic copy of the response packet, excluding the** *Official Bid Price Sheet*, preferably on a flash drive and one (1) hard copy. To the extent possible, all electronic files should be a single document in PDF format.
- B. Official Bid Price Sheet. (See Pricing.)
 - 1. Vendor's original Official Bid Price Sheet must be submitted in hard copy format.
 - 2. Vendor should also submit one (1) electronic copy of the *Official Bid Price Sheet*, preferably on a flash drive, in a single PDF file.
 - 3. The Official Bid Price Sheet, including the hard copy and electronic copy, must be separately sealed from the Bid Response Packet and should be clearly marked as "Pricing." Vendor must not include any pricing in the hard copies or electronic copies of the Bid Response Packet.

1.8 AGREEMENT AND COMPLIANCE PAGES

- A. Vendor **must** sign all *Agreement and Compliance Pages* relevant to each section of the *Bid Solicitation Document*. The *Agreement and Compliance Pages* are included in the Bid *Response Packet*.
- B. Vendor's signature on these pages **shall** signify agreement to and compliance with all requirements within the designated section.

1.9 LIMITED BID SUBMISSION ACCOMMODATION DURING COVID-19

The Arkansas Department of Human Services (DHS) Office of Procurement (OP) extends the following bid submission accommodation to our Prospective Vendors in order to mitigate some of the difficulties presented by the current Covid-19 outbreak.

Prospective Bidders may elect to submit electronic bids via thumb drive only as long as the following conditions are met.

A. All bids must be received by the Bid Submission deadline specified on page 1 of the Bid Solicitation Document.

B. All required response documents must be submitted on a USB flash drive clearly labeled "Response Packet" and sealed in a separate envelope from pricing.

- C. Pricing must be submitted on a separate, clearly marked USB flash drive and sealed in an envelope separate from the Response Packet and clearly marked "Pricing."
- D. By signing the Electronic Submission Signature Page [and Section 1 Vendor Agreement and Compliance page in the Response Packet], Bidder acknowledges and agrees that if the USB flash drives are damaged, malfunction, or the information on them is incompatible with DHS computers or electronic devices or otherwise cannot be accessed or is unusable, the submission will be considered non-responsive and will be disqualified.

In order to mitigate this risk, Bidder may elect to submit bids according to the requirements specified in section 1.7 "Response Documents" of the Bid Solicitation Document or submit additional USB flash drives as backup.

1.10 CLARIFICATION OF BID SOLICITATION

- A. Contractor may submit written questions requesting clarification of information contained in this *Bid Solicitation*. Written questions should be submitted by 4:00 p.m., Central Time on October 30, 2020. Submit written questions by email to the buyer as shown on page one (1) of this *Bid Solicitation*.
- B. The attached response template (*Attachment B*) **must** be used for submission of all written questions. All questions should include the information specified in the response template. Written questions submitted in a different format may not be answered by DHS.
- C. Contractor's written questions will be consolidated and responded to by the State. The State's consolidated written response is anticipated to be posted to the OP website by the close of business on November 6, 2020.
- D. Answers to verbal questions may be given as a matter of courtesy and **must** be evaluated at contractor's risk.

1.11 SUBCONTRACTORS

- A. Vendor **must** complete, sign and submit the *Proposed Subcontractors Form* included in the *Bid Response Packet* to indicate vendor's intent to utilize, or to not utilize, subcontractors.
- B. Additional subcontractor information may be required or requested in following sections of this *Bid Solicitation*. **Do not** attach any additional information to the *Proposed Subcontractors Form*.
- C. The utilization of any proposed subcontractor is subject to approval by the State agency.

1.12 PRICING

- A. Vendor(s) **must** include all pricing on the Official Bid Price Sheet(s) only. Any cost not identified by the successful vendor but subsequently incurred in order to achieve successful operation **shall** be borne by the vendor. The *Official Bid Price Sheet* is provided in the Bid Response Packet.
- B. A justification of prices quoted should be attached to the Official Bid Price Sheet.
- C. To allow time to evaluate bids, prices **must** be valid for one hundred twenty (120) calendar days following the bid opening.
- D. Failure to complete and submit the Official Bid Price Sheet shall result in disgualification.
- E. All bid pricing **must** be in United States dollars and cents.
- F. The Official Bid Price Sheet may be reproduced as needed.
- G. The Official Bid Price Sheet and accompanying price justification **must** be separately sealed from the Bid Response Packet.

1.13 PRIME CONTRACTOR RESPONSIBILITY

A. A joint bid submitted by two (2) or more vendors is acceptable. However, a single vendor **must** be identified as the prime contractor.

B. The prime contractor **shall** be held responsible for the contract and **shall** be the sole point of contact.

1.14 INDEPENDENT PRICE DETERMINATION

- A. By submission of this bid, the vendor certifies, and in the case of a joint response, each party thereto certifies as to its own organization, that in connection with this bid:
 - 1. The prices in the bid have been arrived at independently, without collusion.
 - 2. No prior information concerning these prices has been received from, or given to, a competitive company.
- B. Evidence of collusion **shall** warrant consideration of this bid by the Office of the Attorney General. All vendors **shall** understand that this paragraph may be used as a basis for litigation.

1.15 PROPRIETARY INFORMATION

- A. Submission documents pertaining to this *Bid Solicitation* become the property of the State and are subject to the Arkansas Freedom of Information Act (FOIA).
- B. In accordance with FOIA and to promote maximum competition in the State competitive bidding process, the State may maintain the confidentiality of certain types of information described in FOIA. Such information may include trade secrets defined by FOIA and other information exempted from the Public Records Act pursuant to FOIA.
- C. Prospective Contractor may designate appropriate portions of its response as confidential, consistent with and to the extent permitted under the Statutes and Rules set forth above, by submitting a redacted copy of the response.
- D. By redacting any information contained in the response, the Prospective Contractor warrants that it has formed a good faith opinion having received such necessary or proper review by counsel and other knowledgeable advisors that the portions redacted meet the requirements of the Rules and Statutes set forth above.
- E. Under no circumstances will pricing information be designated as confidential.
- F. One (1) complete copy of the submission documents from which any proprietary information has been redacted should be submitted on a flash drive in the *Bid Response Packet*. A CD is also acceptable. Do not submit documents via email or fax.
- G. Except for the redacted information, the redacted copy **must** be identical to the original hard copy, reflecting the same pagination as the original and showing the space from which information was redacted.
- H. The Prospective Contractor is responsible for identifying all proprietary information and for ensuring the electronic copy is protected against restoration of redacted data.
- The redacted copy will be open to public inspection under FOIA without further notice to the Prospective Contractor.
- J. If a redacted copy of the submission documents is not provided with Prospective Contractor's *Bid Response Packet*, a copy of the non-redacted documents, with the exception of financial data (other than pricing), will be released in response to any request made under FOIA.
- K. If the State deems redacted information to be subject to FOIA, the Prospective Contractor will be contacted prior to release of the documents.

L. The State has no liability to a Prospective Contractor with respect to the disclosure of Prospective Contractor's confidential information ordered by a court of competent jurisdiction pursuant to FOIA or other applicable law.

1.16 CAUTION TO VENDORS

- A. Prior to any contract award, all communication concerning this Bid Solicitation must be addressed through OP.
- B. Vendor must not alter any language in any solicitation document provided by the State.
- C. Vendor **must not** alter the Official Bid Price Sheet.
- All official documents and correspondence related to this solicitation shall be included as part of the resultant contract.
- E. Bids **must** be submitted in the English language.
- F. The State **shall** have the right to award or not award a contract, if it is in the best interest of the State to do so.
- G. Vendor **must** provide clarification of any information in their response documents as requested by OP.
- H. Bids must meet or exceed all defined specifications as set forth in this Bid Solicitation.
- I. Bids **must** meet all terms and conditions of this Invitation for Bid and the laws of the State of Arkansas.
- J. Vendors may submit multiple bids.

1.17 REQUIREMENT OF ADDENDUM

- A. This Bid Solicitation shall be modified only by an addendum written and authorized by OP.
- B. An addendum posted within three (3) calendar days prior to the bid opening **shall** extend the bid opening and may or may not include changes to the Bid Solicitation.
- C. The vendor **shall** be responsible for checking the following websites for any and all addenda up to bid opening: http://www.arkansas.gov/dfa/procurement/bids/index.php, http://humanservices.arkansas.gov/about-dhs/op/procurement-announcements

1.18 AWARD PROCESS

- A. Vendor Selection
 - 1. Award **shall** be made on an ALL OR NONE basis to the lowest responsive bidder. Bidders must meet minimum qualifications. Bids must meet or exceed all defined specifications. Bids must meet all terms and conditions of this Invitation for Bid and the laws of the State of Arkansas.
 - Contract award, extension, or renewal is contingent upon approval by DHS officials, subsequent
 approval by the OP, review by the Legislative Council and the availability of State funds. Changes
 to any non-financial portion of this agreement may be made with the agreement of both DHS and
 the Contractor.

B. Negotiations

- 1. If the State so chooses, negotiations may be conducted with the lowest responsive bidder. Negotiations are conducted at the sole discretion of the State.
- 2. If negotiations fail to result in a contract, the State may begin the negotiation process with the next lowest responsive bidder. The negotiation process may be repeated until the lowest responsive vendor has been determined, or until such time the State decides not to move forward with an award.
- C. Anticipation to Award

1. Once an anticipated successful vendor has been determined, the anticipated award will be posted on the following websites:

- 2. The anticipated award will be posted for a period of fourteen (14) calendar days prior to the issuance of a contract. Vendors and agencies are cautioned that these are preliminary results only, and a contract will not be issued prior to the end of the fourteen (14) day posting period.
- 3. OP **shall** have the right to waive the policy of Anticipation to Award when it is in the best interest of the State.
- 4. It is the vendor's responsibility to check the above referenced websites for the posting of an anticipated award.

D. Issuance of Contract

- 1. Any resultant contract of this Bid Solicitation shall be subject to State approval processes which may include Legislative review.
- 2. An Office of Procurement Official will be responsible for award and administration of any resulting contract.

1.19 MINORITY AND WOMEN-OWNED BUSINESS POLICY

- A. A minority-owned business is defined by Arkansas Code Annotated § 15-4-303 as a business that is at least fifty-one percent (51%) owned by a lawful permanent resident of this State who is:
 - African American
 - American Indian
 - Asian American
 - Hispanic American
- Pacific Islander American
- A Service-disabled Veteran as designated by the United States Department of Veterans Affairs
- B. A woman-owned business is defined by Arkansas Code Annotated § 15-4-303(9) as a business that is at least fifty-one percent (51%) owned by one (1) or more women who are lawful permanent residents of this State.
- C. The Arkansas Economic Development Commission conducts a certification process for minority-owned and women-owned businesses. If certified, the Prospective Contractor's Certification Number should be included on the *Bid Signature Page*.

1.20 EQUAL EMPLOYMENT OPPORTUNITY POLICY

- A. In compliance with Arkansas Code Annotated § 19-11-104, the State is required to have a copy of the anticipated Contractor's *Equal Opportunity (EO) Policy* prior to issuing a contract award.
- B. EO Policies should be included as a hardcopy accompanying the solicitation response.
- C. The submission of an *EO Policy* to the OP is a one-time requirement. Vendors are responsible for providing updates or changes to their respective policies, and for supplying *EO Policies* upon request to other State agencies that must also comply with this statute.
- D. Vendors, who are not required by law by to have an EO Policy, must submit a written statement to that effect.

1.21 PROHIBITION OF EMPLOYMENT OF ILLEGAL IMMIGRANTS

- A. Pursuant to Arkansas Code Annotated § 19-11-105, prior to the award of a contract, selected vendor(s) **must** have a current certification on file with the OP stating that they do not employ or contract with illegal immigrants.
- B. OP will notify the selected vendor(s) prior to award if their certification has expired or is not on file. Instructions for completing the certification process will be provided to the vendor(s) at that time.

1.22 RESTRICTION OF BOYCOTT OF ISRAEL

A. Pursuant to Arkansas Code Annotated § 25-1-503, a public entity **shall not** enter into a contract with a company unless the contract includes a written certification that the person or company is not currently engaged in and agrees for the duration of the contract not to engage in, a boycott of Israel.

- B. This prohibition does not apply to a company which offers to provide the goods or services for at least twenty percent (20%) less than the lowest certifying business.
- C. By checking the designated box on the Bid Signature Page of the response packet, a Prospective Contractor agrees and certifies that they do not, and will not for the duration of the contract, boycott Israel.

1.23 PAST PERFORMANCE

In accordance with provisions of State Procurement Law, specifically OSP Rule R5:19-11-230(b)(1), a vendor's past performance with the State may be used to determine if the vendor is "responsible." Proposals submitted by vendors determined to be non-responsible **shall** be disqualified.

1.24 TECHNOLOGY ACCESS

- A. When procuring a technology product or when soliciting the development of such a product, the State of Arkansas is required to comply with the provisions of Arkansas Code Annotated § 25-26-201 et seq., as amended by Act 308 of 2013, which expresses the policy of the State to provide individuals who are blind or visually impaired with access to information technology purchased in whole or in part with state funds. The Prospective Contractor expressly acknowledges and agrees that state funds may not be expended in connection with the purchase of information technology unless that technology meets the statutory requirements found in 36 C.F.R. § 1194.21, as it existed on January 1, 2013 (software applications and operating ICSs) and 36 C.F.R. § 1194.22, as it existed on January 1, 2013 (web-based intranet and internet information and applications), in accordance with the State of Arkansas technology policy standards relating to accessibility by persons with visual impairments.
- B. Accordingly, the Prospective Contractor expressly represents and warrants to the State of Arkansas through the procurement process by submission of a Voluntary Product Accessibility Template (VPAT) for 36 C.F.R. § 1194.21, as it existed on January 1, 2013 (software applications and operating ICSs) and 36 C.F.R. § 1194.22, that the technology provided to the State for purchase is capable, either by virtue of features included within the technology, or because it is readily adaptable by use with other technology, of:
 - 1. Providing, to the extent required by Arkansas Code Annotated § 25-26-201 et seq., as amended by Act 308 of 2013, equivalent access for effective use by both visual and non-visual means.
 - 2. Presenting information, including prompts used for interactive communications, in formats intended for non-visual use.
 - 3. After being made accessible, integrating into networks for obtaining, retrieving, and disseminating information used by individuals who are not blind or visually impaired.
 - 4. Providing effective, interactive control and use of the technology, including without limitation the operating system, software applications, and format of the data presented is readily achievable by nonvisual means.
 - Being compatible with information technology used by other individuals with whom the blind or visually impaired individuals interact.
 - 6. Integrating into networks used to share communications among employees, program participants, and the public.
 - 7. Providing the capability of equivalent access by nonvisual means to telecommunications or other interconnected network services used by persons who are not blind or visually impaired.
- C. State agencies cannot claim a product as a whole is not reasonably available because no product in the marketplace meets all the standards. Agencies must evaluate products to determine which product best meets the standards. If an agency purchases a product that does not best meet the standards, the agency must

provide written documentation supporting the selection of a different product, including any required reasonable accommodations.

- D. For purposes of this section, the phrase "equivalent access" means a substantially similar ability to communicate with, or make use of, the technology, either directly, by features incorporated within the technology, or by other reasonable means such as assistive devices or services which would constitute reasonable accommodations under the Americans with Disabilities Act or similar state and federal laws. Examples of methods by which equivalent access may be provided include, but are not limited to, keyboard alternatives to mouse commands or other means of navigating graphical displays, and customizable display appearance. As provided in Arkansas Code Annotated § 25-26-201 et seq., as amended by Act 308 of 2013, if equivalent access is not reasonably available, then individuals who are blind or visually impaired **shall** be provided a reasonable accommodation as defined in 42 U.S.C. § 12111(9), as it existed on January 1, 2013.
- E. If the information manipulated or presented by the product is inherently visual in nature, so that its meaning cannot be conveyed non-visually, these specifications do not prohibit the purchase or use of an information technology product that does not meet these standards.

1.25 COMPLIANCE WITH THE STATE SHARED TECHNICAL ARCHITECTURE PROGRAM

The respondent's solution must comply with the state's shared Technical Architecture Program which is a set of policies and standards that can be viewed at: http://dis.publishpath.com/policies-standards. Only those standards which are fully promulgated or have been approved by the Governor's Office apply to this solution.

1.26 VISA ACCEPTANCE

- A. Awarded vendor should have the capability of accepting the State's authorized VISA Procurement Card (p-card) as a method of payment.
- B. Price changes or additional fee(s) **shall not** be levied against the State when accepting the p-card as a form of payment.
- C. VISA is not the exclusive method of payment.

1.27 PUBLICITY

- A. Vendors **shall not** issue a news release pertaining to this *Bid Solicitation* or any portion of the project without OP's prior written approval.
- B. Failure to comply with this Requirement **shall** be cause for a vendor's bid to be disqualified.

1.28 RESERVATION

The State **shall not** pay costs incurred in the preparation of a bid.

Additional days can be proclaimed as holidays by the Governor through executive proclamation. State offices are normally closed on holidays however, there are occasions (i.e. during legislative sessions) when it may become necessary to keep state offices open on holidays. The Contractor shall maintain adequate staff on such working holidays.

SECTION 2 – MINIMUM REQUIREMENTS

2.1 INTRODUCTION

This Invitation for Bid (IFB) is issued by the Department of Human Services (DHS) Office of Procurement (OP) for the Division of Aging, Adult, and Behavioral Health Services (DAABHS) to obtain pricing and a contract(s) for diagnostic laboratory test services for the Arkansas State Hospital, 305 South Palm Street, Little Rock, Arkansas.

The Arkansas State Hospital (ASH) is a psychiatric inpatient facility. ASH's mission is to provide psychiatric services that promote recovery in a safe and caring environment. The hospital has nine (9) units and two hundred twenty-six (226) patient beds in three (3) service areas: General Adult, Forensic, and Adolescent.

The Contractor will perform the majority of the diagnostic laboratory test services and provide sufficient qualified and trained staff to accomplish all required testing. The Contractor is responsible for the on-site collection and transportation of specimen testing for the Arkansas State Hospital (ASH). All services shall be conducted in a professional quality with technical accuracy and timely completion. Submission of all deliverables, services, or commodities shall be in accordance with state and federal specimen testing guidelines.

2.2 SERVICE DELIVERY LOCATION

All services must be provided during normal state work hours and within the agreed upon number of days unless otherwise arranged and coordinated with the agency. The vendor shall give the agency immediate notice of any anticipated delays that will affect the service delivery requirement.

2.3 MINIMUM QUALIFICATIONS

- A. The Contractor must be registered to do business in the State of Arkansas. For verification purposes, Contractor **must** submit official documentation of their active registration from the Arkansas Secretary of State's Office.
- B. The Contractor **shall** have previous and/or current experience working with behavioral health care patients. For verification purposes, bidder **shall** provide three (3) references, including contact name, phone number, address, services provided, and length of service. ASH may contact these references to verify satisfactory delivery of service.
- C. The Contractor **shall** have access to or use of a computer, fax machine, and phone capability in order to receive and send responses to the requesting ASH unit(s). Bidder **shall** provide a statement affirming access to required business equipment.

2.4 SCOPE OF WORK

- A. The Contractor **shall** perform the following duties, described as a minimum, in conjunction with providing laboratory diagnostic testing services under this contract. The Contractor **shall**:
 - Provide on-site (ASH) phlebotomy collection and transport services. These services shall be available twenty-four (24) hours a day and seven (7) days a week. Saturday and Sunday specimen collection, except STAT/Emergency, will be done by ASH.
 - 2. Perform specimen collection and route the specimens to the Contractor's laboratory facility for testing.
 - Provide STAT/Emergency pick-up service on demand. Requests for STAT/Emergency pick-up service may occur at any time of day or night and on any day of the week or weekend.
 - 4. Provide requested diagnostic laboratory testing for all patients referred by ASH.

5. Provide day-to-day supervision of all staff responsible for laboratory services and laboratory support services.

- 6. Provide all expendable laboratory supplies. These supplies shall include but are not limited to:
 - a. urinalysis (UA) and urine drug screening (UDS) collection containers;
 - b. transport bags;
 - c. blood draw tubes;
 - d. vacutainers;
 - e. needles:
 - f. culturette swabs;
 - g. formalin for biopsy containers;
 - h. tourniquets:
 - i. twenty-four (24) hour urine collection containers;
 - j. midstream collection kits;
 - k. urine tubes/caps;
 - I. liquid PAP cups;
 - m. papettes;
 - n. ova and parasite collection kits;
 - o. stool collection containers;
 - p. GC/Chlamydia swabs:
 - q. butterfly needles;
 - r. outpatient cytopathology;
 - s. swabs for Covid-19 and influenza testing; and
 - t. rapid strep test kits.
- 7. Deliver all requested supplies within two (2) regular (excluding weekend and holidays) business days.
- 8. Provide all requisition forms, including pre-printed lab requisition forms, pathology association requisition forms, any other forms that may be necessary in the processing of laboratory tests, and a local or toll-free contact number for ordering laboratory supplies.
- 9. Provide manuals, instructions, etc., needed to accomplish all tasks, including specimen collection, identification, storage, and quality control/quality assurance.
- 10. Provide qualified, certified/licensed, and trained personnel and certified/licensed and approved testing laboratory facilities as required by law for medical laboratory diagnostic testing and services.
- 11. Provide a licensed and qualified Phlebotomist.
- 12. Provide a contact supply person name and phone number.
- 13. Provide the equipment necessary to report results to include connectivity and supplies (paper, ink cartridges, etc.) at no extra charge to ASH.
- 14. Provide back-up procedures to deliver reports when specimens are picked up should the primary method for reporting fail.
- 15. Provide timely responses to any/all questions and/or concerns.
- 16. Accept orders by phone, fax, and/or electronically.
- 17. Correct or revise any errors, omissions, or other deficiencies in its deliverables and other services without any additional compensation.
- 18. Maintain and keep sufficient records to verify billing for all testing.
- 19. Provide an antibiogram for ASH physicians on a quarterly basis.

20. Make the quarterly Laboratory Quality Assurance Reports (LQA) available upon request.

B. Reporting Results

The Contractor's response time to a laboratory diagnostic testing request **must** be timely, determined for the purpose of this contract to mean the following.

- Contractor shall provide an average turnaround time (TAT) for standard tests no later than 09:00am CST, the morning after the specimen is drawn, and provide STAT TAT within one (1) hour and on-call support twenty-four (24) hours a day.
- 2. Verbal reports (via phone) of requested routine tests **must** be available on a same-day basis, unless the test is too complex for this to be feasible. The expectation is that routine lab test results are reported the same business day.
- 3. Contractor **shall** provide preliminary results for cultures within twelve (12) hours and final results within twenty-four (24) to forty-eight (48) hours, dependent upon the specific test.
- 4. Written reports of routine tests **must** be provided electronically as each test is verified or within twenty-four (24) hours of completion of services, depending upon the complexity and length of the analysis.
- 5. Reports **must** to be delivered Monday thru Friday by 2:00PM CST. The weekend reports Saturday and Sunday **must** be delivered on Monday morning (6:00AM CST).
- 6. Contractor **shall** provide a list of critical alert labs which require immediate phone notification. Labs that are not critical in nature, but are out of range, **must** have a mechanism in place to denote the value is out of range and require clinical decision-making.
- 7. All abnormal/critical (life threatening) results **must** be reported by telephone immediately (within fifteen (15) minutes of completion of the test) by the Contractor laboratory personnel to the attending physician and/or unit nurse supervisor. These calls **must** be documented within the laboratory system with the name of ASH personnel, time, and date.
- Contractor shall provide procedures for reporting panic, critical, or very abnormal results that exceed predefined criteria established by the contract. Any and all critical alerts must be reported to the phone number provided by ASH.
- 9. All STAT test results **must** be reported by fax transmission within one (1) hour from the time of the receipt of the request for service.
- 10. Contractor laboratory personnel **must** provide all STAT test requests to the attending physician and/or unit nurse supervisor via telephone.
- 11. Contractor **shall** provide automatic confirmation on positive drug tests.
- 12. Contractor **shall** input daily test results which can be easily accessed and downloaded by authorized ASH personnel. ASH/DHS will assume all rights to data entered.
- 13. The Contractor **shall** maintain all records for a minimum of three (3) years unless advised otherwise by the State. In no case will records be maintained longer than five (5) years. All records shall be subject to the Federal Privacy Act, 5 USC 552a, and other applicable federal and state laws and regulations, and **shall** be maintained and used with the highest regard for patients' privacy.
- 14. The Contractor **shall** be responsible for absorbing any/all cost of merging existing lab reports into electronic medical records.

C. Courier Services

1. Contractor **shall** provide courier service twenty-four (24) hours per day.

2. The phlebotomist **shall** daily, Monday-Friday, 6:00AM CST-9:00PM CST, pick-up any specimen (e.g., UA, UDS, PAP, etc.) and deliver laboratory reports. The phlebotomist **must** remain at ASH for completion of specimen collections and laboratory report delivery; they are not to remain at ASH throughout the entire scheduled time frame but **must** be available during that time frame. However, the phlebotomist **must** be available twenty-four (24) hours a day and seven (7) days a week for collecting and transporting a STAT/Emergency request, which can be made at any time by the attending physician at ASH.

- 3. When a STAT/Emergency situation occurs, the Contractor **shall** arrive at ASH within one (1) hour from receipt of the initial call and results **must** be available within one (1) hour from receipt of specimen. Results of STAT/Emergency testing **must** be available in the computer as soon as testing is complete.
- 4. Pickup and transport of STAT tests **must** be available on an as-requested basis. STAT/Emergency tests **must** be performed at any time, as quickly as staffing and methodology permit, but **must** be collected within one (1) hour of being called.

D. Transport of Specimens

- 1. Contractor shall use universal precautions for collecting and handling all specimens.
- 2. Contractor **shall** deliver all specimens to the laboratory as soon as possible after collection.
- 3. Certain specimens **must** be transported to the laboratory in viral transport media on ice (2-8°C) or refrigerated.
- 4. Urine specimens **must** be transported to the laboratory or refrigerated within thirty (30) minutes. Refrigerated specimens **must** be delivered to the lab as soon as possible.
- 5. All specimens **must** be appropriately labeled with two (2) patient identifiers. Identifiers used at ASH and the Contractor's lab **must** include:
 - patient name
 - birthdate
 - hospital number
- 6. A requisition **must** accompany each different specimen type and include the following:
 - patient's name
 - hospital number
 - hospital service
 - date and time of collection
 - specimen type
 - tests requested
- 7. Specimens **must** be in tightly sealed, leak-proof containers and transported in sealable, leak-proof plastic bags. Specimens for tuberculosis **must** be double bagged. Specimens **must not** be externally contaminated. Specimens grossly contaminated or compromised may be rejected.
- 8. Specimens for bacterial culture **must** be transported at room temperature. If transport is delayed, the following specimens **must** be refrigerated:
 - urine within thirty (30) minutes
 - stool within one (1) hour
 - respiratory specimens
- 9. Specimens for viral culture **must** be transported to the laboratory immediately on ice.
- 10. Contractor **shall** perform daily checks of refrigerators on units A, B, C, 5L and any other venue identified by the Department of Nursing Services for specimen collections.
- 11. Specimen transport **shall** be available twenty-four (24) hours a day seven (7) days a week.

E. Contractor shall receive requests for supplies by courier through the phlebotomists or through fax transmission.

- F. Treatment rooms with phlebotomy chairs are located on each unit's floor of ASH for specimen collection.
- G. The Contractor **shall** provide a secure (enforced through access control, auditing and encryption) and confidential web-based reporting program that exports downloadable daily specimen results of each tested individual.
 - 1. The reporting program **must** be compatible with existing DHS/ASH software (Microsoft Office Word, Excel, Access) and any upgrades to these software programs.
 - The reporting program must be accessed through a secure and protected server provided by the Contractor.
 - 3. The reporting program **must** provide daily access to test results. Access to the Contractor's website **must** be granted to designated ASH personnel twenty-four (24) hours per day.
 - 4. The Contractor's program **shall** offer the capability of retrieving patient's results remotely via secure web access to designated ASH personnel, utilizing their personal iOS (iPhone, iPad) or Android devices.

5. The Contractor's web-based reporting program must meet the following requirements:

H. Data Confidentiality

- All financial, statistical, personnel and/or technical data supplied by ASH to the Contractor are confidential.
 The Contractor shall use reasonable care to protect the confidentiality of such data. Any data storage or
 transmission shall be secure and comply with all state and federal laws, including but not limited to the
 Health Insurance Portability and Accountability Act (HIPAA).
- 2. Any use, sale, or offering of this data in any form by the Contractor, or any individual or entity in the Contractor's charge or employ, **shall** be considered a violation of this contract and may result in contract termination and the Contractor's suspension or debarment from contracting. In addition, such conduct may be reported to the State Attorney General for possible criminal prosecution.

2.5 STAFFING

A. Personnel

- 1. The Contractor **shall** employ only competent and qualified personnel.
- 2. The Contractor **shall** provide a sufficient number of qualified and licensed employees to perform the required services efficiently and in a manner satisfactory to ASH.
- 3. If the Contract Administrator or designee notifies the Contractor in writing that any person employed on this contract is incompetent, disorderly, or otherwise unsatisfactory, such person **shall** be removed from employment in the execution of this contract.
- 4. The Contractor **shall** obtain and maintain in full force and effect all required licenses, permits, and authorizations necessary to perform this contract. The Contractor **shall** supply ASH with evidence of all such licenses, permits, and authorizations.

B. Identification and Dress

- 1. Contractor's employees **shall** dress in a respectable manner and wear a picture identification badge, with their name, occupation, and Contractor's name/logo. Identification badges **must** be worn at all times.
- 2. Upon arrival at ASH, Contractor's employee **must** report to the public safety office to leave their driver's license and collect a set of keys and proximity card in order to gain access to the units.
- 3. Upon departure, Contractor's employee **must** return to the public safety office to turn in keys and proximity card, and their driver's license will be returned to them.

C. Substitution of Staff

- 1. If it becomes necessary for the Contractor to substitute any management, supervisory, or key personnel, the Contractor **shall** identify the substitute personnel and the work to be performed.
- 2. The Contractor **shall** provide detailed justification documenting the necessity for the substitution to the Director of Nursing Services and Chief Compliance Officer.
- The Contractor shall forward a request to substitute staff to the Director of Nursing Services and Chief Compliance Officer for consideration and approval. No substitute personnel shall be authorized to begin work until the Contractor has received written approval to proceed from the Director of Nursing Services and Chief Compliance Officer.
- Certification/license must be submitted as evidence that the individual(s) proposed as substitution(s) have qualifications and experience equal to or better than the individual(s) originally proposed or currently assigned.

2.6 INSURANCE

- A. Before proceeding with any work, the Contractor **shall** furnish to the State a "Certificate of Insurance" executed by an insurance company that has been approved by the State, to evidence coverage by the Contractor as set forth herein, and **shall** keep said insurance in full force throughout the contract period.
- B. Such insurance **shall** be modifiable or cancelable only on written notice from such insurance company and **must** be mailed to ASH/DHS fifteen (15) calendar days in advance of modification or cancellation. The insurance **shall not** be modified without ASH and DAABHS approval.
- C. The insurance **must** contain the following:
 - 1. Liability Limits:
 - Workers Compensation and Employee Fidelity Coverage.
 - Standard limits as outlined by the Contractors' Insurance carrier.
 - a. Workers Compensation and Employees Fidelity Coverage

Workers Compensation statutory limits

Employers Liability \$1,000,000.00 each accident

b. Comprehensive General Liability Policy

Premises and Operation Contractual Insurance Personal Injury

Each Item listed in Section B must have Bodily Injury \$500,000.00 each person \$500,000.00 each occurrence

Property Damage \$1,000,000.00 each occurrence \$1,000,000.00 aggregate

D. Contractor **shall** assume all liability for any accidental or criminal occurrence.

2.7 PERFORMANCE STANDARDS

- A. State law requires that all contracts for services include Performance Standards for measuring the overall quality of services provided. *Attachment C: Performance-Based Contracting* identifies expected deliverables, performance measures, or outcomes; and defines the acceptable standards a vendor **must** meet to avoid assessment of damages.
- B. The State may be open to negotiations of Performance Standards prior to contract award, prior to the commencement of services, or at times throughout the contract duration.
- C. The State **shall** have the right to modify, add, or delete Performance Standards throughout the term of the contract, should the State determine it is in its best interest to do so. Any changes or additions to performance standards will be made in good faith following acceptable industry standards and may include the input of the vendor so as to establish standards that are reasonably achievable.
- D. All changes made to the Performance Standards shall become an official part of the contract.
- E. Performance Standards shall continue throughout the term of the contract.
- F. Failure to meet the minimum Performance Standards as specified **may** result in the assessment of damages or termination of the contract.
- G. In the event a Performance Standard is not met, the vendor will have the opportunity to defend, respond to, or cure to as determined by the State, the insufficiency. The State may waive damages if it determines there were extenuating factors beyond the control of the vendor that hindered the performance of services or it is in the best interest of the State. In these instances, the State shall have final determination of the performance acceptability.

Should any compensation be owed to the agency due to the assessment of damages, vendor **shall** follow the direction of the agency regarding the required compensation process.

SECTION 3 – GENERAL CONTRACTUAL REQUIREMENTS

• **Do not** provide responses to items in this section.

3.1 PAYMENT AND INVOICE PROVISIONS

- A. All invoices **shall** be forwarded to: [Insert invoicing address]
- B. Payment will be made in accordance with applicable State of Arkansas accounting procedures upon acceptance goods and services by the agency.
- C. The State **shall not** be invoiced in advance of delivery and acceptance of any goods or services.
- D. Payment will be made only after the vendor has successfully satisfied the agency as to the reliability and effectiveness of the goods or services purchased as a whole.
- E. The vendor should invoice the agency by an itemized list of charges. The agency's Purchase Order Number and/or the Contract Number should be referenced on each invoice.
- F. Other sections of this Bid Solicitation may contain additional requirements for invoicing.
- G. Selected vendor **must** be registered to receive payment and future *Bid Solicitation* notifications. Vendors may register on-line at https://www.ark.org/vendor/index.html.

3.2 **GENERAL INFORMATION**

- A. The State **shall not** lease any equipment or software for a period of time which continues past the end of a fiscal year unless the contract allows for cancellation by the State Procurement Official upon a 30-calendar day written notice to the vendor/lessor in the event funds are not appropriated.
- B. The State **shall not** contract with another party to indemnify and defend that party for any liability and damages.
- C. The State **shall not** pay damages, legal expenses or other costs and expenses of any other party.
- D. The State **shall not** continue a contract once any equipment has been repossessed.
- E. Any litigation involving the State must take place in Pulaski County, Arkansas.
- F. The State **shall not** agree to any provision of a contract which violates the laws or constitution of the State of Arkansas.
- G. The State **shall not** enter a contract which grants to another party any remedies other than the following:
 - 1. The right to possession.
 - 2. The right to accrued payments.
 - 3. The right to expenses of deinstallation.
 - 4. The right to expenses of repair to return the equipment to normal working order, normal wear and tear excluded.
 - 5. The right to recover only amounts due at the time of repossession and any unamortized nonrecurring cost as allowed by Arkansas Law.
- H. The laws of the State of Arkansas **shall** govern this contract.
- I. A contract shall not be effective prior to award being made by a State Procurement Official.
- J. In a contract with another party, the State will accept the risk of loss of the equipment or software and pay for any destruction, loss or damage of the equipment or software while the State has such risk, when:

1. The extent of liability for such risk is based upon the purchase price of the equipment or software at the time of any loss.

2. The contract has required the State to carry insurance for such risk.

3.3 CONDITIONS OF CONTRACT

- A. The vendor **shall** at all times observe and comply with federal and State of Arkansas laws, local laws, ordinances, orders, and regulations existing at the time of, or enacted subsequent to the execution of a resulting contract which in any manner affect the completion of the work.
- B. The vendor shall indemnify and save harmless the agency and all its officers, representatives, agents, and employees against any claim or liability arising from or based upon the violation of any such law, ordinance, regulation, order or decree by an employee, representative, or subcontractor of the vendor.
- C. The Contractor agrees to the Performance-Based Contracting standards as presented in Attachment C, DHS Standard Terms and Conditions as presented in Attachment D, a pro forma contract as presented in Attachment E, the Business Associate Agreement as presented in Attachment F, and the Organizational or Personal Conflict of Interest policy as presented in Attachment G.

ALL VENDOR STAFF MAY BE MANDATED REPORTERS UNDER STATE AND FEDERAL MANDATES

3.4 STATEMENT OF LIABILITY

- A. The State will demonstrate reasonable care but will not be liable in the event of loss, destruction or theft of vendor-owned equipment or software and technical and business or operations literature to be delivered or to be used in the installation of deliverables and services. The vendor **shall** retain total liability for equipment, software and technical and business or operations literature. The State **shall** not at any time be responsible for or accept liability for any vendor-owned items.
- B. The vendor's liability for damages to the State **shall** be limited to the value of the Contract or five million dollars (\$5,000,000), whichever is higher. The foregoing limitation of liability **shall not** apply to claims for infringement of United States patent, copyright, trademarks or trade secrets; to claims for personal injury or damage to property caused by the gross negligence or willful misconduct of the vendor; to claims covered by other specific provisions of the Contract calling for damages; or to court costs or attorney's fees awarded by a court in addition to damages after litigation based on the Contract. The vendor and the State **shall not** be liable to each other, regardless of the form of action, for consequential, incidental, indirect, or special damages. This limitation of liability **shall not** apply to claims for infringement of United States patent, copyright, trademark or trade secrets; to claims for personal injury or damage to property caused by the gross negligence or willful misconduct of the vendor; to claims covered by other specific provisions of the Contract calling for damages; or to court costs or attorney's fees awarded by a court in addition to damages after litigation based on the Contract.
- C. Language in these terms and conditions **shall not** be construed or deemed as the State's waiver of its right of sovereign immunity. The vendor agrees that any claims against the State, whether sounding in tort or in contract, **shall** be brought before the Arkansas State Claims Commission as provided by Arkansas law, and **shall** be governed accordingly.

3.5 RECORD RETENTION

- A. The vendor **shall** maintain all pertinent financial and accounting records and evidence pertaining to the contract in accordance with generally accepted principles of accounting and as specified by the State of Arkansas Law. Upon request, access **shall** be granted to State or Federal Government entities or any of their duly authorized representatives.
- B. Financial and accounting records **shall** be made available, upon request, to the State of Arkansas's designee(s) at any time during the contract period and any extension thereof, and for five (5) years from expiration date and final payment on the contract or extension thereof.
- C. Other sections of this Bid Solicitation may contain additional requirements regarding record retention.

3.6 PRICE ESCALATION

- A. Price increases will be considered at the time of contract renewal.
- B. The vendor **must** provide to the Office of Procurement (OP) a written request for the price increase. The request **must** include supporting documentation demonstrating that the increase in contract price is based on an increase in market price. OP **shall** have the right to require additional information pertaining to the requested increase.
- C. Increases **shall not** be considered to increase profit or margins.
- D. OP shall have the right to approve or deny the request.

3.7 CONFIDENTIALITY

- A. The vendor, vendor's subsidiaries, and vendor's employees **shall** be bound to all laws and to all requirements set forth in this *Bid Solicitation* concerning the confidentiality and secure handling of information of which they may become aware of while providing services under a resulting contract.
- B. Consistent and/or uncorrected breaches of confidentiality may constitute grounds for cancellation of a resulting contract, and the State **shall** have the right to cancel the contract on these grounds.
- C. Previous sections of this Bid Solicitation may contain additional confidentiality requirements.

3.8 CONTRACT INTERPRETATION

Should the State and vendor interpret specifications differently, either party may request clarification. However, if an agreement cannot be reached the determination of the State **shall** be final and controlling.

3.9 CANCELLATION

- A. <u>For Cause</u>. The State may cancel any contract resulting from this solicitation for cause at the discretion of the Arkansas Department of Human Services. The State shall give the vendor written notice of cancellation, specifying the terms and the effective date of contract termination.
- B. <u>For Convenience</u>. The State may cancel any contract resulting from the solicitation by giving the Contractor written notice of such cancellation no less than thirty (30) calendar days prior to the date of cancellation.
- C. If upon cancellation the Contractor has provided commodities or services which the State of Arkansas has accepted, and there are no funds legally available to pay for the commodities or services, the Contractor may file a claim with the Arkansas Claims Commission under the laws and regulations governing the filing of such claims.

3.10 **SEVERABILITY**

If any provision of the contract, including items incorporated by reference, is declared or found to be illegal, unenforceable, or void, then both the agency and the vendor **shall** be relieved of all obligations arising under such provision. If the remainder of the contract is capable of performance, it **shall not** be affected by such declaration or finding and **shall** be fully performed.

SECTION 4 – STANDARD TERMS AND CONDITIONS

- **Do not** provide responses to items in this section.
- GENERAL: Any special terms and conditions included in this solicitation shall override these Standard Terms and Conditions. The Standard Terms and Conditions and any special terms and conditions shall become part of any contract entered into if any or all parts of the bid are accepted by the State of Arkansas.
- 2. ACCEPTANCE AND REJECTION: The State shall have the right to accept or reject all or any part of a bid or any and all bids, to waive minor technicalities, and to award the bid to best serve the interest of the State.
- 3. **BID SUBMISSION**: Original Bid Packets **must** be submitted to the Office of State Procurement on or before the date and time specified for bid opening. The Bid Packet **must** contain all documents, information, and attachments as specifically and expressly required in the *Bid Solicitation*. The bid **must** be typed or printed in ink. The signature **must** be in ink. Unsigned bids **shall** be disqualified. The person signing the bid should show title or authority to bind the firm in a contract. Multiple bids **must** be placed in separate packages and should be completely and properly identified. Late bids **shall not** be considered under any circumstances.
- 4. PRICES: Bid unit price F.O.B. destination. In case of errors in extension, unit prices shall govern. Prices shall be firm and shall not be subject to escalation unless otherwise specified in the *Bid Solicitation*. Unless otherwise specified, the bid must be firm for acceptance for thirty (30) days from the bid opening date. "Discount from list" bids are not acceptable unless requested in the *Bid Solicitation*.
- 5. **QUANTITIES**: Quantities stated in a *Bid Solicitation* for term contracts are estimates only and are not guaranteed. Contractors **must** bid unit price on the estimated quantity and unit of measure specified. The State may order more or less than the estimated quantity on term contracts. Quantities stated on firm contracts are actual Requirements of the ordering agency.
- 6. BRAND NAME REFERENCES: Unless otherwise specified in the *Bid Solicitation*, any catalog brand name or manufacturer reference used in the *Bid Solicitation* is descriptive only, not restrictive, and used to indicate the type and quality desired. Bids on brands of like nature and quality will be considered. If bidding on other than referenced specifications, the bid **must** show the manufacturer, brand or trade name, and other descriptions, and should include the manufacturer's illustrations and complete descriptions of the product offered. The State **shall** have the right to determine whether a substitute offered is equivalent to and meets the standards of the item specified, and the State may require the Contractor to supply additional descriptive material. The Contractor **shall** guarantee that the product offered will meet or exceed specifications identified in this *Bid Solicitation*. Contractors not bidding an alternate to the referenced brand name or manufacturer **shall** be required to furnish the product according to brand names, numbers, etc., as specified in the solicitation.
- 7. GUARANTY: All items bid shall be newly manufactured, in first-class condition, latest model and design, including, where applicable, containers suitable for shipment and storage, unless otherwise indicated in the Bid Solicitation. The Contractor hereby guarantees that everything furnished hereunder shall be free from defects in design, workmanship and material, that if sold by drawing, sample or specification, it shall conform thereto and shall serve the function for which it was furnished. The Contractor shall further guarantee that if the items furnished hereunder are to be installed by the Contractor, such items shall function properly when installed. The Contractor shall guarantee that all applicable laws have been complied with relating to construction, packaging, labeling and registration. The Contractor's obligations under this paragraph shall survive for a period of one (1) year from the date of delivery, unless otherwise specified herein.
- 8. SAMPLES: Samples or demonstrators, when requested, must be furnished free of expense to the State. Each sample should be marked with the Contractor's name and address, bid or contract number and item number. If requested, samples that are not destroyed during reasonable examination will be returned at Contractor's expense. After reasonable examination, all demonstrators will be returned at Contractor's expense.
- 9. TESTING PROCEDURES FOR SPECIFICATIONS COMPLIANCE: Tests may be performed on samples or demonstrators submitted with the bid or on samples taken from the regular shipment. In the event products tested fail to meet or exceed all conditions and requirements of the specifications, the cost of the sample used, and the reasonable cost of the testing shall be borne by the Contractor.
- 10. AMENDMENTS: Contractor's bids cannot be altered or amended after the bid opening except as permitted by regulation.
- 11. TAXES AND TRADE DISCOUNTS: Do not include State or local sales taxes in the bid price. Trade discounts should be deducted from the unit price and the net price should be shown in the bid.
- 12. AWARD: Term Contract: A contract award will be issued to the successful Contractor. It results in a binding obligation without further action by either party. This award does not authorize shipment. Shipment is authorized by the receipt of a purchase order from the ordering agency. Firm Contract: A written State purchase order authorizing shipment will be furnished to the successful Contractor.
- 13. DELIVERY ON FIRM CONTRACTS: This solicitation shows the number of days to place a commodity in the ordering agency's designated location under normal conditions. If the Contractor cannot meet the stated delivery, alternate delivery schedules may become a factor in an award. The Office of State Procurement shall have the right to extend delivery if reasons appear valid. If the date is not acceptable, the agency may buy elsewhere, and any additional cost shall be borne by the Contractor.

14. **DELIVERY REQUIREMENTS**: No substitutions or cancellations are permitted without written approval of the Office of State Procurement. Delivery **shall** be made during agency work hours (8:00 a.m. to 4:30 p.m. Central Time) unless prior approval for other delivery has been obtained from the agency. Packing memoranda **shall** be enclosed with each shipment.

- 15. STORAGE: The ordering agency is responsible for storage if the Contractor delivers within the time required and the agency cannot accept delivery.
- 16. **DEFAULT**: All commodities furnished **shall** be subject to inspection and acceptance of the ordering agency after delivery. Back orders, default in promised delivery, or failure to meet specifications **shall** authorize the Office of State Procurement to cancel this contract or any portion of it and reasonably purchase commodities elsewhere and charge full increase, if any, in cost and handling to the defaulting Contractor. The Contractor **must** give written notice to the Office of State Procurement and ordering agency of the reason and the expected delivery date. Consistent failure to meet delivery without a valid reason may cause removal from the Contractors list or suspension of eligibility for award.
- 17. VARIATION IN QUANTITY: The State assumes no liability for commodities produced, processed or shipped in excess of the amount specified on the agency's purchase order.
- **18. INVOICING**: The Contractor **shall** be paid upon the completion of all of the following: (1) submission of an original and the specified number of copies of a properly itemized invoice showing the bid and purchase order numbers, where itemized in the *Bid Solicitation*; (2) delivery and acceptance of the commodities; (3) proper and legal processing of the invoice by all necessary State agencies. Invoices **must** be sent to the "Invoice To" point shown on the purchase order.
- 19. STATE PROPERTY: Any specifications, drawings, technical information, dies, cuts, negatives, positives, data or any other commodity furnished to the Contractor hereunder or in contemplation hereof or developed by the Contractor for use hereunder shall remain property of the State, shall be kept confidential, shall be used only as expressly authorized, and shall be returned at the Contractor's expense to the F.O.B. point provided by the agency or by OSP. Contractor shall properly identify items being returned.
- 20. PATENTS OR COPYRIGHTS: The Contractor must agree to indemnify and hold the State harmless from all claims, damages and costs including attorneys' fees, arising from infringement of patents or copyrights.
- 21. ASSIGNMENT: Any contract entered into pursuant to this solicitation shall not be assignable nor the duties thereunder delegable by either party without the written consent of the other party of the contract.
- 22. CLAIMS: Any claims the Contractor may assert under this Agreement shall be brought before the Arkansas State Claims Commission ("Commission"), which shall have exclusive jurisdiction over all claims that the Contactor may have arising from or in connection with this Agreement. Unless the Contractor's obligations to perform are terminated by the State, the Contractor shall continue to provide the Services under this Agreement even if the Contractor has a claim pending before the Commission.
- 23. CANCELLATION: In the event, the State no longer needs the commodities or services specified for any reason, (e.g., program changes; changes in laws, rules or regulations; relocation of offices; lack of appropriated funding, etc.), the State shall have the right to cancel the contract or purchase order by giving the Contractor written notice of such cancellation thirty (30) days prior to the date of cancellation.
 - Any delivered but unpaid for goods will be returned in normal condition to the Contractor by the State. If the State is unable to return the commodities in normal condition and there are no funds legally available to pay for the goods, the Contractor may file a claim with the Arkansas Claims Commission under the laws and regulations governing the filing of such claims. If upon cancellation the Contractor has provided services which the State has accepted, the Contractor may file a claim. **NOTHING IN THIS CONTRACT SHALL BE DEEMED A WAIVER OF THE STATE'S RIGHT TO SOVEREIGN IMMUNITY.**
- 24. **DISCRIMINATION**: In order to comply with the provision of Act 954 of 1977 relating to unfair employment practices, the Contractor agrees that: (a) the Contractor **shall not** discriminate against any employee or applicant for employment because of race, sex, color, age, religion, handicap, or national origin; (b) in all solicitations or advertisements for employees, the Contractor **shall** state that all qualified applicants **shall** receive consideration without regard to race, color, sex, age, religion, handicap, or national origin; (c) the Contractor will furnish such relevant information and reports as requested by the Human Resources Commission for the purpose of determining compliance with the statute; (d) failure of the Contractor to comply with the statute, the rules and regulations promulgated thereunder and this nondiscrimination clause **shall** be deemed a breach of contract and it may be cancelled, terminated or suspended in whole or in part; (e) the Contractor **shall** include the provisions of above items (a) through (d) in every subcontract so that such provisions **shall** be binding upon such subcontractor or Contractor.
- 25. CONTINGENT FEE: The Contractor guarantees that no one has been retained to solicit or secure this contract upon an agreement or understanding for a commission, percentage, brokerage or contingent fee, except for retention of bona fide employees or bona fide established commercial selling agencies maintained by the Contractor for securing business.
- 26. ANTITRUST ASSIGNMENT: As part of the consideration for entering into any contract pursuant to this solicitation, the Contractor named on the *Bid Signature Page* for this solicitation, acting herein by the authorized individual or its duly authorized agent, hereby assigns, sells and transfers to the State of Arkansas all rights, title and interest in and to all causes of action it may have under the antitrust laws of the United States or this State for price fixing, which causes of action have accrued prior to the date of this assignment and which relate solely to the particular goods or services purchased or produced by this State pursuant to this contract.

27. **DISCLOSURE**: Failure to make any disclosure required by Governor's Executive Order 98-04, or any violation of any rule, regulation, or policy adopted pursuant to that order, **shall** be a material breach of the terms of this contract. Any Contractor, whether an individual or entity, who fails to make the required disclosure or who violates any rule, regulation, or policy **shall** be subject to all legal remedies available to the agency.
